## Minor Permission & Release Form

I understand that as part of the Contest, the Minor will be part of a video voluntarily submitted to the Globe as entry into and participation in the Contest and posted on YouTube, the Globe's website, the Globe's social media accounts or any other Internet web site or digital distribution channel. I further understand that if the Minor is part of the winning band in the Contest, said Minor will perform on the premises of the Globe on Thursday, March 29, 2018, as well as win tickets to certain Globe productions, as determined solely by the Globe, and share in a cash prize of \$500, said distribution of the cash prize to be determined solely by the band members participating in the Contest. If the Minor is part of a band that wins second or third prize in the Contest, Minor will win tickets to certain Globe productions as determined solely by the Globe.

I understand the Minor may be photographed and videotaped while participating in this Contest by photographers and videographers acting on behalf of the Globe and Globe-approved industry and media representatives. I consent to such recording of the Minor, their voice and likeness. I grant to the Globe the right to copyright, use, publish, reproduce, display, distribute, create derivative works from, license and otherwise use any photos or footage, in whole or in part, of the Minor, their voice and likeness in any media and in any manner in perpetuity, including for internet, broadcast, and similar; for purposes including but not limited to in highlights videos and other marketing material without any compensation to me. I waive any right that I may have to inspect and approve the finished product or copy that may be used in connection with an image that the photographer and/or videographer has taken of the Minor during the Contest, or the use to which it may be applied.

I hereby release the Globe and/or any of its authorized representatives from any and all harm, liability or damage from any physical injury or property losses the Minor may suffer which may result from participating in the Contest and/or performing at the Globe. In consideration of the Minor being permitted by the Globe to participate in the Contest and/or perform at the Globe, I, the undersigned, represent and affirm that I am the parent or legal guardian of the Minor whose name appears above. I understand and agree that the above terms and conditions apply to the Minor and to me. I further agree to indemnify and hold harmless the Globe and its representatives from any and all claims which are brought by, or on behalf of the Minor and which are in anyway connected with the Minor's participation in the Contest or in performing at the Globe.
